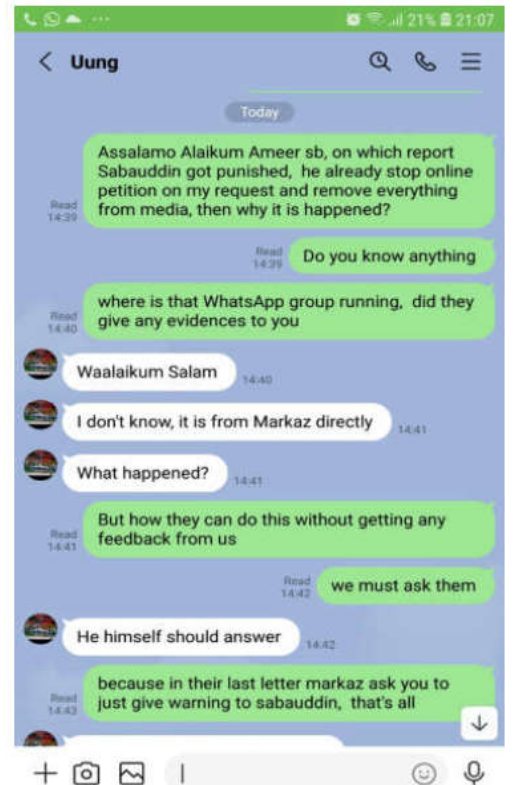

**Mr. Adnan Khan Sahib is as follows:**

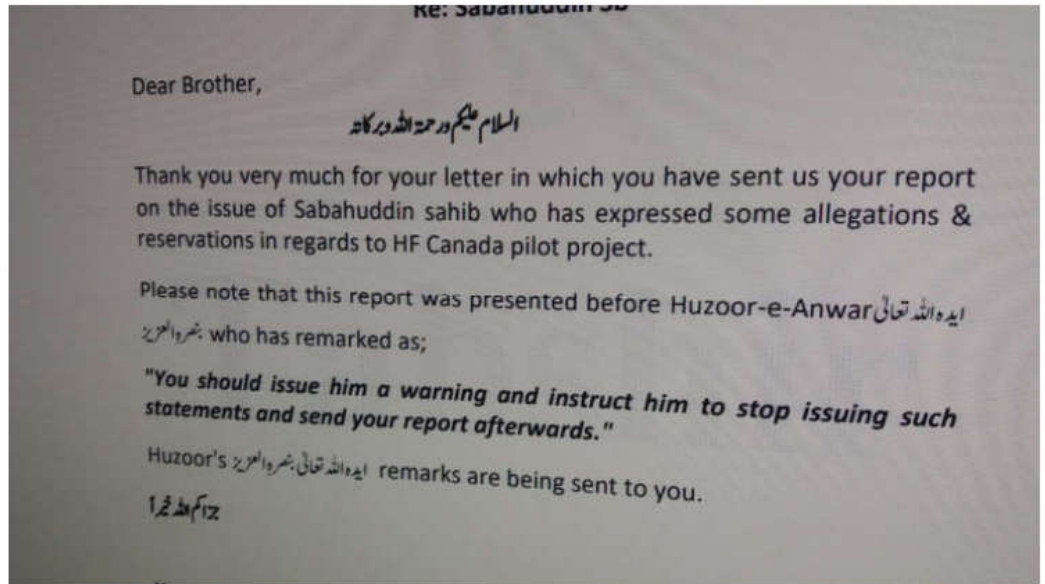

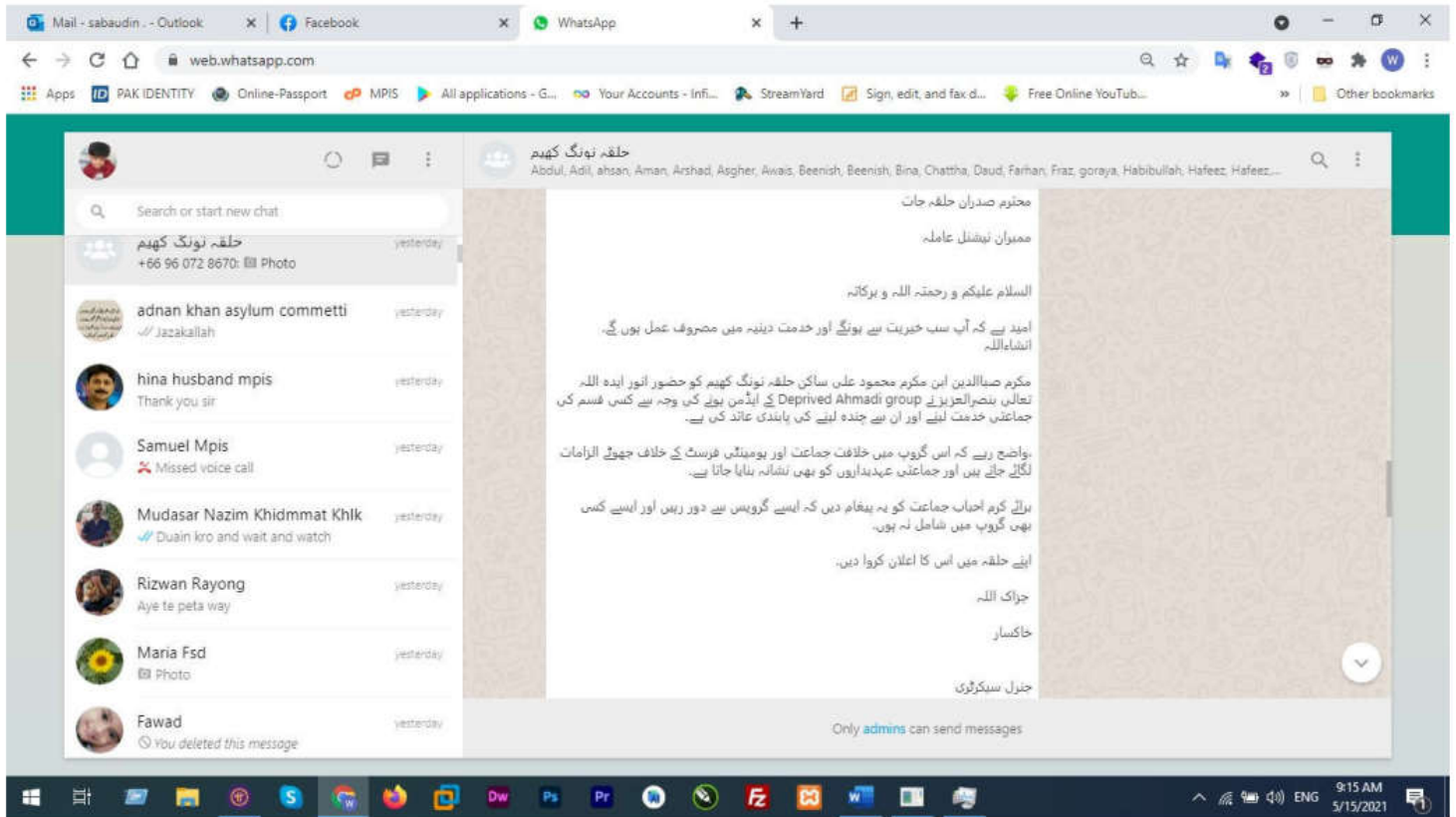
I don't know what Tabsheer office want this. Jazakallah

Below is an inquiry made by National Sec amoor ama to those who were admins of that group.



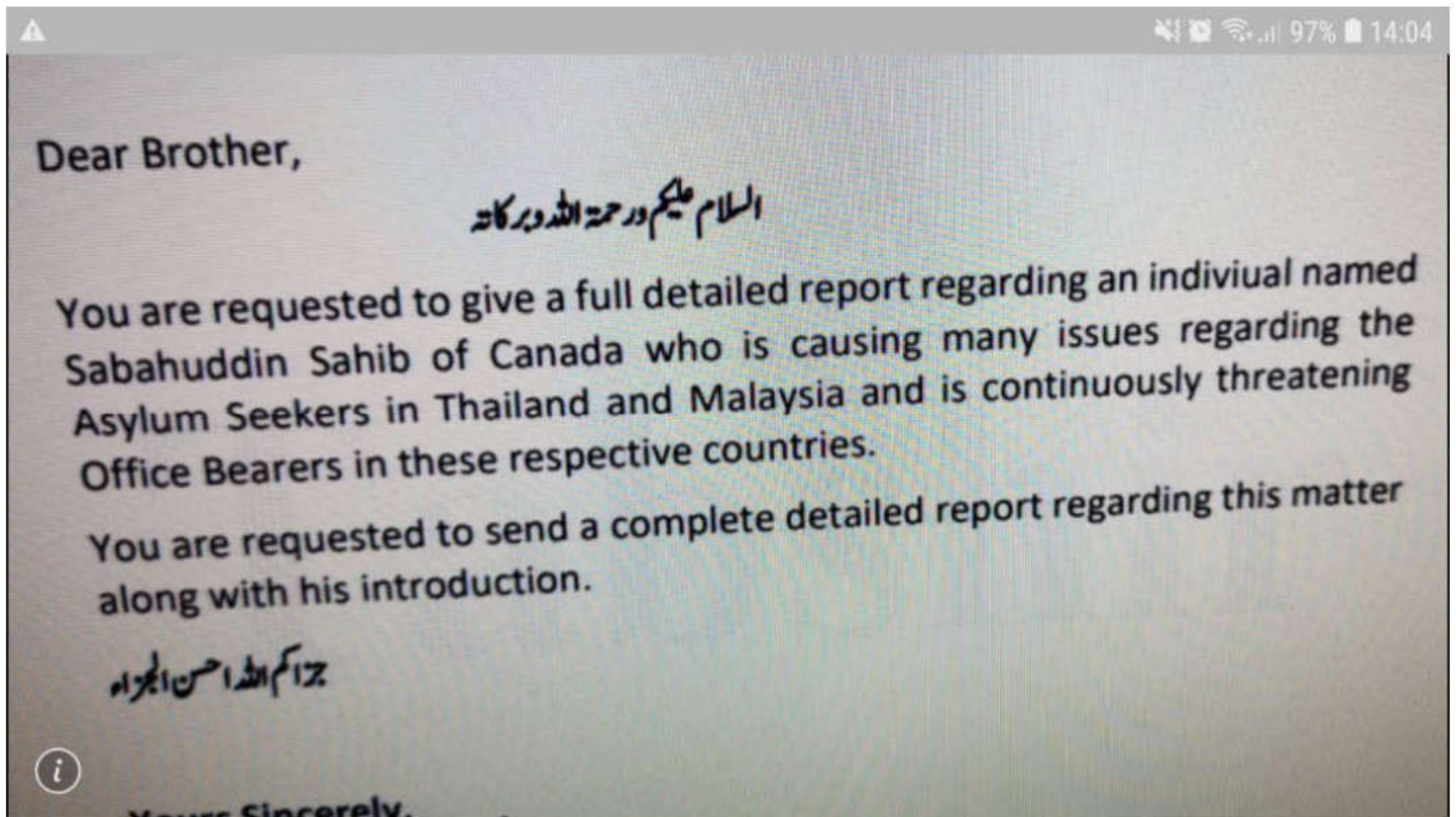
Below is the announcement of the Wrong Tazeer on social Media.

I am a refugee in Thailand and there is an organization in Canada named Humanity First

they in their website mention about refugee resettlement and details are mentioned in the above mentioned website.

But when contact with for process they asked the amount from the refugee itself that if I want my self to be sponsored to Canada I have to pay the amount that will be paid me back on monthly basis as of my monthly expenses.

the process is not like as mentioned in website the actual process that I faced is as follows:

I have to transfer amount 42700 CAD (5 family members fee) to humanity first's any personal account they promised to give one.

then they will fill out my forms for immigration and will submit file to Canada immigration.

after it is approved and everything goes well i will reach Canada as a permanent resident (refugee) and then I can not apply for any Government bases assistance until one year. During this one year they will pay me back my amount in partials to fulfil my monthly expenses.

I wanted to End this cruelty because people with resources are getting refugee status from UNHCR and then they pay money to humanity First and then they resettled to Canada and the poor one like me are suffering here just because of Humanity First Canada

If you really want to help people like your organization Name Humanity First please help them without any money transfer you get donations from public and Governments utilize that amount to sponsor refugees how a refugee can pay you and those who already paid you they are still waiting here from more than last 2 years.

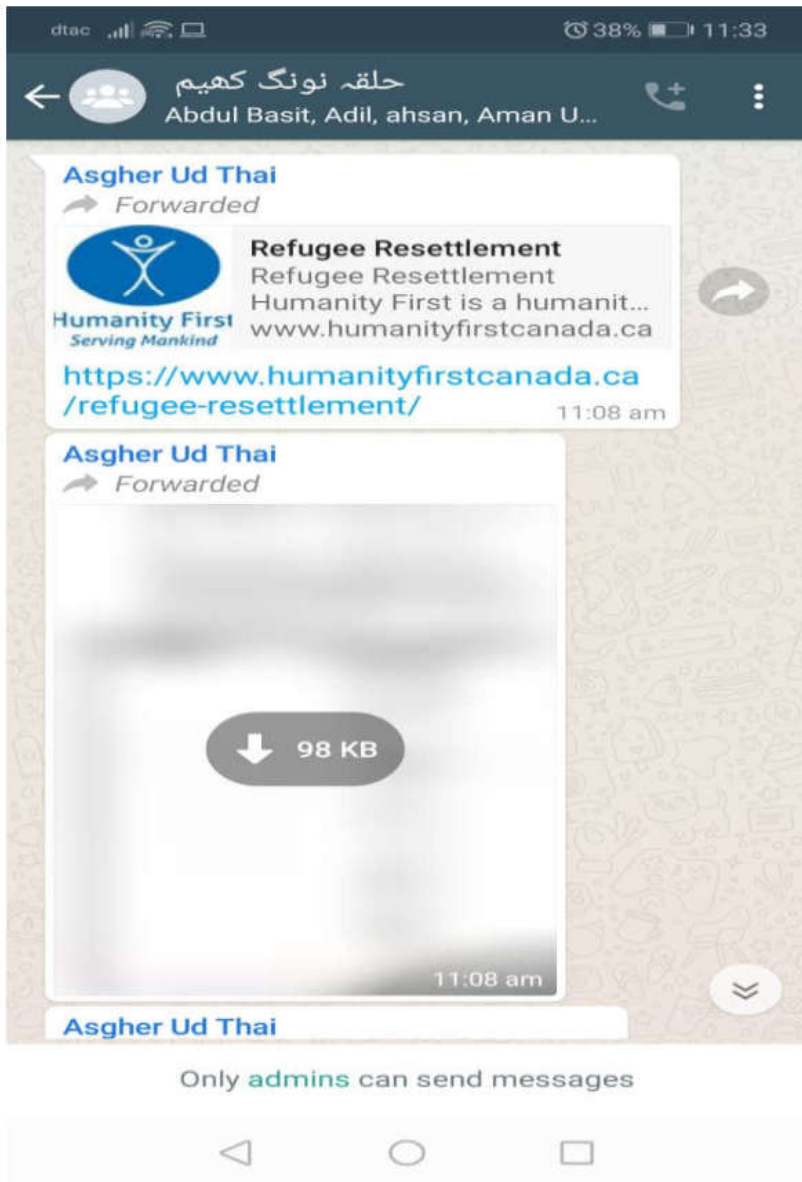

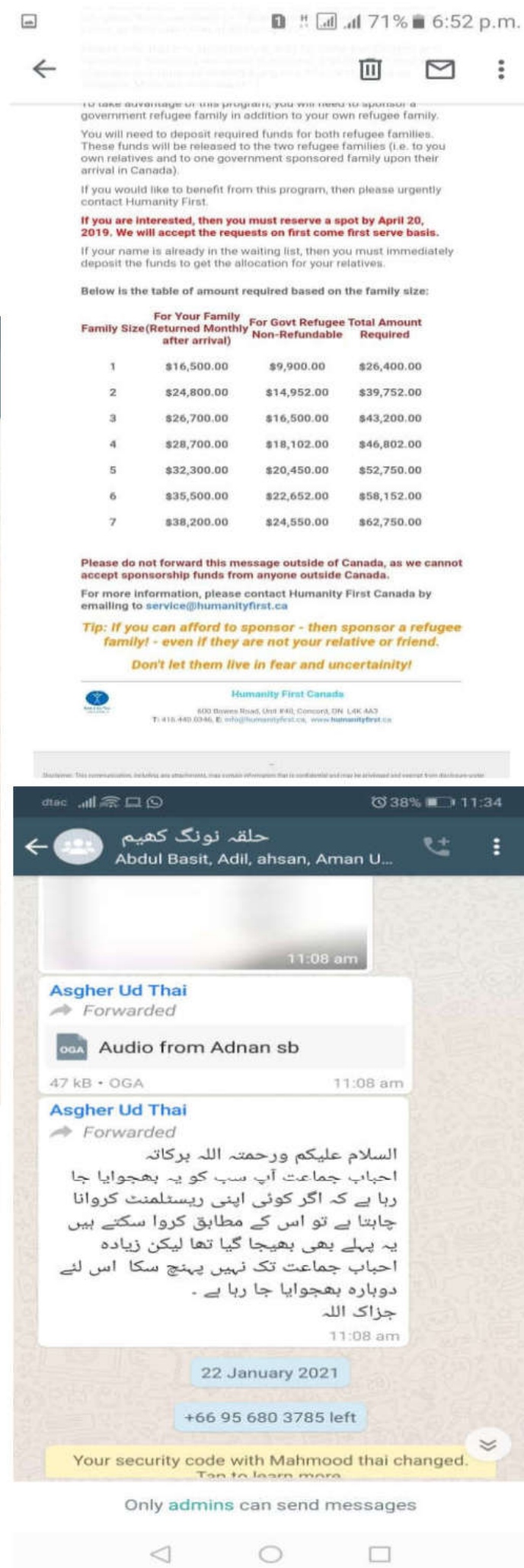
Right after few hours of this petition when I started it Sec Amoor ama Thailand asked me to remove it and I removed it instantly. This petition was online for a few hours.

This screenshot is the pilot project which is also a paid Resettlement Program offered by Humanity First Canada.

Due to this Project people with resources and money were able To move to Canada while it is illegal to ask money from a refugee For his resettlement. Why I am saying this that refugees pays For this project themselves below is again a screenshot.



These messages were shared in Jamaati Groups all over Thailand That those refugees who can afford to pay their resettlement To Canada through Humanity first Canada They can utilize This program to move to Canada. Asghar Sahib who shared these messages in Jamaati Groups is National General Secretary Thailand.



A lot of refugees sold their assets to arrange this money for their resettlement to Canada some also took loans from their relative in other countries and I can assure you that not a single person within Canada contributed for this sponsor program all money goes from Pakistan or other countries.

And for your complete knowledge no one who paid for this pilot project is able to go to Canada since 2017.

And now those people are sending their voice recordings in whats groups that we paid dollars to humanity first Canada and now Mr Aslam daud Sahib (Chairman Humanity First Canada) is not replying to their emails. Will share those audios in other episode of this matter because I do not want any problem for those.

### **Anyways again this matter has nothing to do with being an admin of a whatsapp group.**

SO this Tazeer is technically, emotionally and legally wrong not a word of this tazeer is true about me. I am innocent and will be innocent Insha'Allah.

I also sent everything about this matter to Hazur (aba) through Faxes.

Again This humanity first matter is something else and Being admin of a whatsapp group is something else.

So I do not accept this wrong tazeer and I wanted to bring this matter under attention of Beloved Hazur (aba).

Because my children and Mine waqf is cancelled by Waqf e nau international.

I am not sure why jamaat is not looking at the problem, instead creating new problems by sending wrong tazeer.

This is a fact that Humanity First Canada took money in order to resettle refugees to Canada but this matter is not linked in anyway to that whats group which jamaat says that I am admin of that group. I am not Admin Nor member of any whatsapp group named Deprived Ahmdi Refugees.

So Kindly see into this matter thoroughly because Some high Level Office bearers do not want to expose Humanity First Canada instead they are blaming me in wrong tazeer and involving me in those matters which are not true.

Jmaat Canada lied to Hazur (aba) That I am admin of that whatsapp group just because I asked some questions from markaz about Humanity First Canada's Paid Project.

In addition to this matter I also received threats from Rabwa My cousin his name is Mansoor Ahmed sahib brother of Hafiz Muzaffar ahmad sahib Additional Nazir Islah o irshaad Rabwah received a call from Amoomi Rabwah that ask Saba u din to stop his case about Humanity First Canada in Markaz or their will be consequences. Assalamu Alaikum wa Rahmatullahi wa Barakatuhu

We have received a Memorandum from Thailand Jama'at in which you have been restricted from Jama'at activities.

Under the guidance of Hazoor-e-Anwar (*Aba*) if the Waqifeen-e-Nau parents are restricted from the Jama'at activities or excommunicated, the Waqifeen-e-Nau children will also be excluded from the Waqf-e-Nau scheme. Under this guidance you are being excluded from the Waqf-e-Nau scheme. Furthermore, under this guidance **Fawad Saba Uddin (Previous WN Ref. 36190B)**, **Hibbatul Basit Saba Uddin (Previous WN Ref. 31760B)** and **Saleha Saba Uddin (Previous WN Ref. 27645B)** are all being excluded from the Waqf-e-Nau scheme.

I would like to inform you that all your names have been deleted from the Waqf-e-Nau record. This action has been taken according to the guidance of Hazoor (*Aba*).
